**Chairperson's Report for 2014 as required under  
the Code of Practice for the Governance of State Bodies and  
Section 28(4) of the Harbours Acts 1996-2009  
Port of Cork Company and its Subsidiary Undertakings**

**Introduction:**

In 2014 Port of Cork and Bantry traffic amounted to 10.15 million tonnes compared to 10.6 million tonnes in 2013 which represented a decrease of 445,164 tonnes or 4.2%. While container traffic at the Tivoli Container Terminal increased by 13%, dry bulk cargoes decreased due to the improved weather conditions for farmers in the summer of 2014. Turnover in 2014 amounted to €24.8 million up from €23.3 million in 2013. Profit on Ordinary Activities before Taxation amounted to €2.7 million compared to €1.7 million in 2013, an increase of €1 million or 56%.

Achievements in 2014 at the Port of Cork include:

- The achievement of a Profit before Taxation of €2.7 million compared to €1.7 million in 2013, an increase of 56%;
- The creation of a subsidiary Bantry Bay Port Company Limited (BBPC) to manage the Bantry Bay operation;
- The approval in May of a new Pension Funding Proposal by The Pensions Authority;
- Container traffic at the Tivoli Container Terminal increased to 179,854 TEU's compared to 158,849 TEU's in 2013, an increase of 13.2%;
- The preparation and submission of a Planning Application for key Port Infrastructure Proposals in Ringaskiddy to An Bord Pleanála and the completion of an efficient Strategic Infrastructure Oral Hearing in September;
- Progress with the Successful Ten-T Funding Application including the appointment of Financial Transaction Advisors to assess and evaluate potential sources of finance in a comprehensive financial appraisal which demonstrates the commercial viability of the proposed Ringaskiddy developments;
- The submission of a new TEN-T application in February 2015;
- Securing a Planning Permission in December 2014 for upgrading the Cruise Berthing Facilities in Cobh expected to cost €1.6 million approximately as part of a Cruise Vision to accommodate the maximum sized cruise vessels;
- The screening by TV3 of "Cork Mega Port" a fly on the wall four one hour TV documentary series specifically on the Port of Cork;
- The celebration of the 200<sup>th</sup> Anniversary of Cork Harbour Commissioners and the Port of Cork and the publication of a book on the history of Cork Harbour Commissioners "Portraiture of Cork Harbour Commissioners";
- Constant engagement with Key Customers;
- The amalgamation and consolidation of the Bantry Bay Harbour Commissioners assets and Pilotage arrangements from the 1<sup>st</sup> January 2014;
- ISO14001, OHSAS 18001 and IPSEM accreditations.

**€503,861 Dividend payment to Department of Transport Tourism and Sport:**

The Board of Directors of the Port of Cork Company approved a dividend payment to the Exchequer of €503,886 in May 2014 (2013: €407,094), being 30% of the Company's 2013 Profit after Taxation. It is the policy of the Port of Cork Company to continue to pay a yearly dividend in the amount of 30% of profits available for

distribution excluding Bantry Bay Port Company Limited profits. The Company intends to pay a dividend of circa. €650,000 (increase of 20%) in 2015 while also pursuing its capital strategic development plan and achieving a reduction in its pension fund deficit.

#### **Trade Performance:**

In 2014, oil traffic at the Philips 66 Whitegate Oil Refinery decreased by 1.5% to 4.8 million tonnes. The Oil Refinery accounts for over 55% of the freight and 28% of ship tonnage and goods income of the Port of Cork. Whitegate Oil Refinery is critical to both the Port of Cork and the oil supply chain nationally. Bantry traffic (Whiddy) amounted to 1.3 million tonnes in 2014, and this traffic is now consolidated with the Port of Cork Company.

Non-oil traffic amounted to 4 million tonnes compared to 4.2 million tonnes in 2013, a decrease of 213,885 tonnes or 5% primarily due to decreased dry bulk cargos, (i.e. cereals, animal feedstuffs, fertilisers, salt, coal etc.) following improved weather conditions for farmers in the summer of 2014. The combined port's container traffic for Tivoli and Ringaskiddy increased to 191,228 TEU's, an overall increase of 20,818 TEU's or 12.22%.

While imports of trade vehicles increased by 24.8% to 33,009 vehicles, liquid petroleum gas and exports of lead and zinc concentrates all decreased. Towage operations were significantly ahead of 2013 at 592 tows, representing an increase of 12.33%. Brittany Ferries continued on the tourist ferry route from Cork to Roscoff, running every Saturday from March to October 2014.

#### **Container Handling Facilities at Tivoli:**

Traffic at the Tivoli Container Terminal continued to grow in January and February 2015. In late February 2015, the Board of Directors approved a further expansion of the Tivoli container terminal to accommodate this traffic growth, including installation of additional reefers, moving an adjacent licence tenant to a different location in the Tivoli Industrial Estate and the purchase of second hand Straddle Carriers.

#### **Container & Bulk Handling Facilities at Ringaskiddy:**

The Port of Cork has a container handling facility at the Ringaskiddy Deepwater Terminal which enables the Port of Cork and global shipping company, Maersk, to maintain a direct deep-sea Trans-Atlantic service to Ireland from South America and the Caribbean. This service facilitates the importation of fruit and the export of Irish produce. The Port of Cork invested €4 million to facilitate this service, with the development of a container compound and the purchase of a new electric RTG (Rubber Tyred Gantry Crane). In addition in June 2013 the Port took delivery of a €3m new Liebherr LMH 550 Harbour Mobile Crane to enhance our container and bulk handling facilities and attract more deep-sea services into the Port of Cork.

These investments demonstrate the Port of Cork's commitment to continue to grow business and in turn, provide a much needed stimulus in Ireland's import and export trade. The vessels accommodated at Ringaskiddy are the largest which can be accommodated in Ireland, thus highlighting the deep-water capabilities of the Port of Cork.

#### **Port Redevelopment at Ringaskiddy:**

The limitations at the existing Lo-Lo facilities in the Tivoli Container Terminal (water depth, width for vessel swinging, landside terminal capacity) requires the relocation of the container business downstream to the lower harbour at Ringaskiddy. Maritime

traders want to get in and get out of the harbour as quickly as possible. If the Port of Cork Company does not move from the unsustainable infrastructure at Ringaskiddy the Port will certainly go into decline. The Port re-development will be beneficial to the Port, Port Customers, the City, the wider Cork Community and the Region.

The Company lodged a Planning Application for new Port Infrastructure in Ringaskiddy with An Bord Pleanála on Thursday 1<sup>st</sup> May 2014 and a Strategic Infrastructure Oral Hearing was completed in September 2014 where all stakeholder views were considered. A decision by An Bord Pleanala is expected before the end of May 2015.

Following the publication of the National Ports Policy, the Minister asked the NRA to prioritise the development of the N28 upgrade. The upgrading of the N28 roadway will come with this Ringaskiddy redevelopment and this will benefit Local Residents, Industry and Commuters in the Ringaskiddy and Carrigaline areas.

#### **TEN-T:**

The Port of Cork Company was successful in early July 2013 with its funding application made under “The Acceleration/Facilitation for the implementation of TEN-T projects”. This priority addressed activities alleviating bottle-necks and promoting cross-border connectivity at European level through financially assisting Preparatory Studies (e.g. feasibility, environmental and design studies) concerning the development of projects with the aim to create a mature project, where EU added value is clearly demonstrated. Fifty percent grant aid was made available to obtain statutory consents for the Ringaskiddy development, complete financial and economic appraisals, detailed designs, communication plan and prepare tender documents.

#### **2015 TEN-T Funding Application:**

The Port of Cork was named as part of the TEN-T North Sea-Mediterranean Priority Corridor, along with being identified as a Tier 1 Port in the National Ports Policy. The aim of Connecting Europe Facility (CEF) TEN-T funding is to support the implementation of the core network. The North-Sea Mediterranean Corridor Workplan was published on the 22<sup>nd</sup> December 2014. It is expected to be formally adopted by the European Parliament in March 2015. One of the recommendations of the Corridor Co-ordinator is that “Interconnectivity – In the North and West of the Corridor, where accessibility from the island regions is the critical issue, there is a need to develop Motorways of the Sea, and to improve hinterland connections at the seaports. To solve these issues, projects like the Port infrastructure and Ringaskiddy road connection in Cork ... should be encouraged”

Therefore, a new application for TEN-T Transport Section CEF Funding was submitted to the European Commission DG-Move (Directorate General for Mobility and Transport) on the 23<sup>rd</sup> February 2015 following Department of Transport Tourism & Sport endorsement on the 20<sup>th</sup> February 2015. A decision as to the eligibility of applications is likely to be announced in July 2015.

#### **Whitegate Oil Refinery:**

In 2013 Phillips 66 engaged the services of Deutsche Bank for the purpose of selling the Whitegate Oil Refinery and related business along with the storage facility at Whiddy Island in Bantry Bay. During the first half of 2014, Phillips 66 abandoned its plans to sell the Whitegate Refinery, while the sale of the oil storage facility at Whiddy to Zenith Energy, a USA based oil storage company was completed in February 2015.

The Port of Cork Company management are in regular contact with senior personnel in Phillips66 regarding the Whitegate Oil Refinery facility. The Oil refinery accounts

for over 55% of the freight traffic through the Port of Cork and is critical to Cork and the wider regional economy.

#### **Bantry Bay Harbour Assets:**

During 2013, the Minister of Transport Tourism & Sport, completed a Public Consultation process in respect of his proposal to transfer responsibility for Bantry Bay Harbour to the Port of Cork Company (PoCC).

Having considered the submissions made and other relevant issues, the Minister decided that the transfer to PoCC should proceed and that a subsidiary Company should be established by PoCC to manage Bantry Harbour. Crowley DFK, Chartered Accountants, completed a Due Diligence of Bantry Bay Harbour Commissioners in July 2013 and subsequently assisted the Company prepare a Business Case for the amalgamation of Bantry Bay Harbour and the Port of Cork Company.

Ministerial consent was then received to form a subsidiary Bantry Bay Port Company Limited (BBPC) to operate Bantry Harbour. The Department of Transport Tourism & Sport agreed that the PoCC should issue 2,255,633 nominal shares at a cost of €1.25 each giving a value of €2,819,542 to the Minister for Transport Tourism & Sport to complete the transfer of Bantry Bay Harbour assets into the Port of Cork Company Balance Sheet as at 1 January 2014. The completion of the amalgamation and consolidation of the Bantry Bay Harbour assets and Pilotage arrangements into the Port of Cork was achieved during the first half of 2014.

#### **Bantry Bay Port Company Limited immediate Objectives:**

In the first half of 2014, BBPC prepared a Business Plan for years 2014-2016 with the immediate objectives agreed as follows:

- To put in place all required procedures, systems and controls including Health & Safety, Security, Internal Financial Control Procedures and Environmental;
- To develop and improve the business, trade and cruise throughput of the Port Company;
- To ensure that the Port Company complies with all regulatory matters including audit, corporate governance and risk management;
- To have in place the appropriate facilities and plant to service the needs of existing and potential customers;
- To continue to promote marine leisure and tourism, and be supportive of relevant community initiatives in Bantry Bay; and
- To advance Phase 1 of the inner harbour remedial and capital works as proposed and discussed with the Department of Transport Tourism & Sport.

#### **IDA Landswap:**

As part of the IMERC project at Ringaskiddy the Port of Cork Company are committed to the transfer of lands under its control, in consideration for IDA lands, to University College Cork for the construction of a new Hydraulic Laboratory and Maritime Research Centre, incorporating the Cork Maritime Research Centre. Government funding has been allocated for the project to UCC and they have obtained the necessary planning permission. The transfer of 1.3 hectares of Port of Cork Company lands for 3.2207 hectares of IDA lands of equal value was completed during 2014. The Port of Cork Company issued a licence to UCC, while awaiting progress on a second landswap with the IDA, for a second area of land for the purpose of the construction of a service road and associated underground services.

### **Marino Point:**

The Marino Point site has for a long time been identified as a suitable Port site to complement facilities in Ringaskiddy. The site has:

- Rail connectivity;
- An Existing Jetty – 10m draft – Access and Berthage;
- Seveso designation on site – thereby presenting an opportunity to facilitate relocation of other Seveso sites from Tivoli and the City; and
- Significant development potential as a Cork Harbour Port site.

However, the site also has a number of potential challenges related to planning, licence consents, bridge and road access and the cost of redevelopment.

In 2014, the Port of Cork Company sourced partners who agreed to jointly acquire and redevelop the Marino Point site with the Port of Cork Company to have a 20% interest in this Joint Venture subject to Ministerial approval. In December 2014, the Port of Cork Company requested Ministerial approval to acquire 20% of the Share Capital of a JV Company purchasing Marino Point having submitted a business and financial analysis case which demonstrated that the project complies with the Department of Finance Guidelines and with the legal requirement for the Port of Cork Company to enter into a JV as a 20% Shareholder. The Minister is considering this application and a formal response is awaited.

### **Cork City Docklands Development:**

The Port of Cork Company maintains its support for the Cork Docklands redevelopment and intends playing a full role in ensuring the potential of the area is realised.

### **Tourism:**

Cobh is synonymous with a lot of the Harbour's history and today boasts that it is home to Ireland's only dedicated Cruise terminal. Vessels up to 340m in length can currently be accommodated. In 2014, 58 cruise liners with a gross tonnage of 3.5 million tonnes, brought over 120,000 passengers and crew to the region and this year 2015, 54 cruise liners with a gross tonnage of 4 million tonnes, are scheduled to call carrying a similar amount of passengers and crew. Planning consent was granted by Cork County Council on the 22<sup>nd</sup> December 2014 for the first phase of redevelopments at the Cobh Deepwater Cruise terminal. This redevelopment will provide sufficient mooring infrastructure and water depth to accommodate Quantum Class cruise vessels (350m length) at the current cruise terminal using existing berthing facilities.

The combination of the Spike Island - Cobh / Titanic / Lusitania and Harbour Forts represents a unique tourism opportunity for the region. The Port is actively involved in these projects and believes the new experiences they offer are complementary to Cruise traffic. A Lusitania Commemoration Ceremony "Lusitania Remembered" will be held on the 7<sup>th</sup> May 2015 in Cobh and President Michael D. Higgins is scheduled to attend. The Port is investigating additional access points across the Harbour.

Cobh Maritime Development Company Limited was formed in March 2013 as a non-trading "special purpose entity" involving Cork County Council, Cork City Council, Cobh Urban District Council and the Port of Cork Company. The sole purpose of this entity is to develop an area in the Cobh Railway Station to offer tourists and cruise passengers additional facilities and exhibition accommodation.

### **Leisure and Recreation Strategy:**

In developing a Leisure and Recreation Strategy for Cork and Bantry Harbours, the Company has identified a number of initiatives for further development of the marine recreation sector, thereby helping and supporting an important source of enjoyment and economic gain for residents and visitors alike.

The Port of Cork City Marina proved to be a major addition to Cork City and is widely used by local and visiting boats. The Marina facilitates a number of events including Cork Harbour Open Day, Ocean to City and the Cobh to Blackrock race. The Company, through its Corporate Social Responsibility Policy continues to have wide involvement with all Port stakeholders and Harbour Community Groups including recent developments at Monkstown and Aghada.

Bantry Bay Port Company Ltd is planning to organise a Maritime Art Exhibition in Bantry House in the summer of 2015, with a view to supporting local leisure, recreation and tourism.

### **Developing Tourism potential:**

The Ports of Cork and Bantry are active participants in a number of initiatives aimed at developing the tourism potential in Cork and Bantry Harbours. These include participating in the Cork County Council Spike Island working group, the Cork Harbour Management Group, working with the Cobh and Harbour Chamber of Commerce, the Bantry Bay User Forum and the Whiddy Island Association.

It is the view of the Company that considerable potential exists for commercial tourism opportunities in the Harbours which would support the growth of the established cruise and other tourism related businesses. The interpretation of the rich maritime, emigration and trading history of Cork Harbour and Bantry can, in time, generate sustainable businesses and employment opportunities. The Company intends to play a leading role in this area, by the development of its business and supporting the economic development and job potential of this region.

### **Defined Benefit Pension Fund Deficit:**

The Port of Cork Company operates defined benefit pension schemes for employees who joined the Company prior to the 6<sup>th</sup> March 2006. For employees recruited after 6<sup>th</sup> March 2006, the Company operates a Defined Contribution Pension Scheme.

Details regarding the Port of Cork Company Pension Schemes-Actuarial Valuation and FRS17 Disclosures are included in note 26 to the annual Financial Statements attached.

### **Immediate Priorities:**

The immediate priorities of the Port of Cork Company are to:

- Continue growth at the Ports of Cork and Bantry through renewed competitiveness, investment and profitability for the long term and continued engagement with all of our customers;
- Significantly reshape and rightsize port infrastructure for a long term and viable future; and
- Assist regional economic development opportunities to the fullest in the areas of Tivoli, Ringaskiddy, Cobh, Cork Docklands and Bantry developments, through promotion of tourism, maritime research and industrial expansion.

**Intreoir:**

**Íocaíocht díbhinne de €503,861 leis an Roinn Iompair, Turasóireachta agus Spóirt:**

D’fhaomhaigh Bord Stiúrthóirí Chuideachta Phort Chorcaí íocaíocht díbhinne don Státhiste de €503,886 i Mí na Bealtaine 2014, (2013: €407,094), sin 30% de Bhrabús na Cuideachta do 2013 tar éis Cánachais. Is é polasaí Chuideachta Phort Chorcaí ná leanúint uirthi de bheith ag íoc díbhinne bliantúla ar mhéid 30% den bhrabús atá ar fáil do dháileadh, gan brabús Chuideacha Phort Chuain Bhá Bheanntraí a chur san áireamh. Tá sé i gceist ag an gCuideachta díbhinn a íoc de thart ar €650,000 (sin méadú de 20%) i 2015 agus í fós i mbun a pleann forbartha caipitung straitéisigh a chur i gcrích agus í ag baint amach laghdaithe ina heasnamh ciste phinsin.

## **Feidhmíocht Trádála:**

I 2014 chuaigh an trácht Ola ag Scaglann Ola Philips66' sa Gheata Bán i laghad faoi 1.5% go 4.8 milliún tona. An Scaglann Ola atá i gceist le breis is 55% de mhéid lastais trácht agus 28% de thonnáiste loinge agus ioncam earraí Phort Chorcaí. Tá Scaglann Ola an Gheata Bháin ríthábhachtach do Phort Chorcaí agus don slabhra soláthair ola go náisiúnta. Ba é méid an tráctica i mBeantraí (Faoide) ná 1.3 milliún tona i 2014, agus tá an trácht seo comhdhlúthaithe anois le Cuideachta Phort Chorcaí.

Bhí méid an tráctica neamhola ag 4 milliún tona, le hais 4.2 mhilliún tona i 2013, sin laghdú de 213,885 tona nó 5%, go príomha mar gheall ar mhéid laghdaithe lastas builc thirim (.i. gránbharra, bianna ainmhithe, leasacháin, salann, gual, srl.) tar éis d'fheabhas a bheith tagtha ar an aimsir le haghaidh na feirmeoírí i samhradh 2014. Mhéadaigh comhthrácht coimeádáin na bPort i Tivoli agus i Rinn an Scidígh go 191,228 TEU, sin méadú iomlán de 20,818 TEU nó 12.22%.

Chuaigh iompórtálacha feithiclí trádála i méid faoi 24.8% go 33,009 feithicil, ach chuaigh iompórtálacha gáis pheitrialam leachtaithe agus easpórtálacha tiúchán luaidhe agus since ar fad i laghad. Bhí oibriúcháin tuála chun tosaigh go suntasach ar leibhéal 2013, ag 592 tuáil, sin méadú de 12.33%. Lean Brittany Ferries orthu lena mbealach báid thurasóireachta ó Chorcaigh go Roscoff, a bhí ar siúl gach Satharn ó Mhí Mhárta go Mí Dheireadh Fómhair 2014.

## **Áiseanna Láimhseála Coimeádán ag Tivoli:**

Leanadh ar aghaidh le fás an tráctica ag Críochfoirt Coimeádáin Tivoli i Mí Eanáir agus i Mí Feabhra 2015. Go déanach i Mí Feabhra 2015, d'fhaomhaigh Bord na Stiúrthóirí leathnú breise chríochfort coimeádáin Tivoli chun freastal a dhéanamh ar an bhfás tráctica seo, rud a chuimseoidh suiteáil chuisnuithe breise, aistriú tionóna ceadúnais cóngarach go hionad eile in Eastát Tionsclaiochta Tivoli agus ceannach Iompróirí Scaradh Gabhail dara láimhe.

## **Áiseanna Láimhseála Coimeádáin agus Bulclasta ag Rinn an Scidígh:**

Tá áis láimhseála coimeádáin ag Port Chorcaí ag Críochfort Domhainuisce Rinn an Scidígh a chuireann ar chumas Phort Chorcaí agus na cuideachta domhanda loingseoireachta, Maersk, seirbhís dhíreach dhomhainfharraige Thrasatlantach a chothabháil go hÉirinn ó Mheiriceá Theas agus ón Muir Chairib. Éascaíonn an tseirbhís seo iompórtáil torthaí agus easpórtáil earraí Éireannacha. D'infheistigh Port Chorcaí €4 mhilliún chun an áis seo a éascú, le forbairt bhábhúin do choimeádáin agus le ceannach CDBR nua leictrigh (sin Crann Droichid le Boinn Rubair). Ina theannta sin i Mí Mheithimh 2013 seachadadh don Phort Craein Nua Shoghluaise Chuain Liebherr LMH 550, ar luach €3 mhilliún, le feabhas a chur ar ár gcuid áiseanna láimhseála coimeádáin agus builc agus le cabhrú le níos mó gnólachtaí domhainmhara a mhealladh go Port Chorcaí.

Léiríonn an infheistíocht seo tiomantas Phort Chorcaí do bheith ag leanúint air de bheith ag méadú leibhéal an ghnó agus lena sheal sin, le spreagadh a bhfuil géarghá leis a sholáthar do thrádáil iompórtála agus easpórtála na hÉireann. Tá na soithí sin a dtugtar cóiríocht dóibh i Rinn an Scidígh ar na cinn is mó ar féidir cóiríocht a thabhairt dóibh in Éirinn, rud a chuireann béim ar acmhainní domhainfharraige Phort Chorcaí.

## **Athfhorbairt an Phoirt ag Rinn an Scidígh:**

Éilíonn na srianta atá i bhfeidhm ag na háiseanna reatha Lo-Lo ag Tivoli, (doimhneacht uisce, leithead do ghluaisceacht soithí, toilleadh críochfoirt thaobh na talún) éilíonn siad athlonnú an ghnó choimeádáin cún le sruth chuirg an gcuán íochtarach ag Rinn an Scidígh. Is mian le trádálaithe muirí dul isteach sa chuan agus é a fhágáil chomh luath agus is féidir. Mura n-aistrítear Cuideachta Phort Chorcaí ón infrastruchtúr neamh-iniomparttha i Rinn an Scidígh is cinnte go rachaidh an Port i léig. Rachaidh athfhorbairt an Phoirt chun tairbhe an Phoirt, Chustaiméirí an Phoirt, Phobal Chorcaí i gcoitinne, agus an Réigiún.

Lóisteáil an Chuideachta Iarratas Pleanála le haghaidh Infrastruchtúir nua Poirt i Rinn an Scidígh leis an mBord Pleanála Déardaoin 1 Bealtaine 2014 agus cuireadh Éisteacht ó bhéal faoi Infrastruktúr Straitéiseach i gcrích i Mí Mheán Fómhair 2014, ócáir ina ndearnadh breithniú faoi thuairimí na bpáirtithe leasmhara ar fad. Táthar ag súil le socrú ón mBord Pleanála roimh dheireadh Mhí na Bealtaine 2015.

Tar éis fhoilsiú an Pholasaí Náisiúnta um Phoirt d'iarr an tAire ar an ÚBN (an tÚdarás um Bóithre Náisiúnta) tosaíocht a dhéanamh d'uasghrádú an N28. Déanfar uasghrádú an bhóthair N28 in éineacht le hathfhorbairt Rinn an Scidígh agus rachaidh sin chun tairbhe na gCónaitheoirí Áitiúla, agus Lucht an Tionscail agus na gComaitéirí i gceantar Rinn an Scidígh agus i gceantar Charraig Uí Leighin.

### **TEN-T:**

D'éirigh le hiarratas maoinithe Chuideachta Phort Chorcaí go luath i Mí Iúil 2013, iarratas a rinneadh faoin gcatagóir “Luathú / Éascú do chur i bhfeidhm thionscadail TEN-T”. Thug an tosaíocht seo aghaidh ar ghníomhaíochtaí le bacanna a fhuascailt agus nascacht trastearann a chothú ag leibhéal na hEorpa trí chabhair airgeadais a thabhairt do Staidéir Ullmhúcháin (m.sh. staidéir fhéidearthachta, thimpeallachta agus dheartha) i dtaca le forbairt tionscadal agus é mar aidhm tionscadal aibí a chruthú, mar a léirítear breislúach an AE go soiléir. Cuireadh cabhair dheontais caoga faoin gcéad ar fáil chun toilithe reachtúla a fháil d'fhorbairt Rinn an Scidígh, breithmheasanna críochnúla airgeadais agus eacnamaíocha, dearadh mionsonraithe, pleán cumarsáide agus chun doiciméid tairisceana a ullmhú.

### **Iarratas Maoinithe TEN-T 2015:**

Ainmníodh Port Chorcaí mar chuid de Chonair Thosaíochta TEN-T na Mara Thuaidh-na Meánmhara, agus aithníodh é mar Phort Sraith 1 i bPort Náisiúnta. Is í an aidhm atá le maoiniú Áis Naschta na hEorpa (ÁNE) TEN-T ná le tacú le cur i bhfeidhm an chroílínra. Foilsíodh Pleán Oibre Chonair na Mara Thuaidh-na Meánmhara ar 22 Nollaig 2014. Táthar ag súil leis go nglacfaidh Parlaimint na hEorpa leis go foirmeálta i Mí Mhárta 2015. Seo a leanas ceann de mholtáí Chomhordaitheoir na Conaire: “Idirnascthacht – I dTuaisceart agus in Iarthar na Conaire, mar a bhfuil inrochtaineacht ó réigiún na n-oileán ina ceist ríthábhachtach, tá gá ann le Mótarbhealaí na Farraige a fhorbairt, agus le naisc chúlchríche a fheabhsú ag na calafoirt. Chun na ceisteanna seo a réiteach ba chóir tionscadail cosúil le tionscadal infrastruktúr an Phoirt agus nasc bóthair Rinn an Scidígh i gCorcaigh ... a spreagadh.”

Cuireadh, mar sin de, iarratas nua ar Mhaoiniú ÁNE Rannóige Iompair TEN-T faoi bhráid DG-Move (Ard-Stiúrthóireacht na Soghluaiseachta agus an Iompair) ar 23 Feabhra 2015 tar éis tacáiocht a fháil ón Roinn Iompair, Turasóireacht & Spóirt ar 20 Feabhra 2015. Is dócha go bhfógrófar socrú maidir le hincháilitheacht na n-iarratas i Mí Iúil 2015.

### **Scaglann Ola an Gheata Bháin:**

I 2013 ghlac Phillips 66 le seirbhísí Deutsche Bank chun cuspóirí díolacháin Scaglann Ola an Gheata Bháin chomh maith le gnó gaolmhar in éineacht leis an áis stórais ag Oileán Fhaoide i mbÁ Bheanntraí. Le linn chéad leath 2014 d'éirigh Phillips 66 as a gcuideachta stórála ola ag Faoide do Zenith Energy, cuideachta stórála ola ó SAM, cuireadh sin i gcrích i Mí Feabhra 2015.

Tá lucht bainistíochta Chuideachta Phort Chorcaí i dteagmháil go rialta le pearsanra sinsearach Phillips66 maidir le háis Scaglann Ola an Gheata Bháin. Téann 55% den trácht lastais a théann trí Phort Chorcaí tríd an Scaglann Ola agus tá sí ríthábhachtach do Chorcaigh agus don gheilleagar réigiúnach.

### **Sócmhainní Cuain Bhá Bheanntraí:**

Le linn 2013, chuir an tAire Iompair, Turasóireacht & Spóirt próiseas Comhairliúcháin Phoiblí i gcrích i dtaca lena thogra go ndéanfaí freagracht as Cuan Bhá Bheanntraí a aistriú go Cuideachta Phort Chorcaí (CPC).

Tar éis dó breithniú a dhéanamh faoi na haighneachtaí a rinneadh agus faoi cheisteanna ábhartha eile, shocraigh an tAire gur chóir dul ar aghaidh leis an aistriú go CPC agus gur chóir fochuideachta a bhunú ag CPC chun Cuan Bheanntraí a bhainistiú. Chuir Crowley DFK, Cuntasóirí Cairte, Dícheall Cuí i gcrích do Choimisinéirí Cuain Bhá Bheanntraí i Mí Iúil 2013 agus ina dhiaidh sin chabhraigh siad leis an gCuideachta le Cás Gnó a dhéanamh ar son chónascadh Chuain Bhá Bheanntraí agus Chuideachta Phort Chorcaí.

Ansin fuarthas comhthoil ón Aire le Fochuideachta Theoranta Phort Bhá Bheanntraí a bhunú le cuan Bheanntraí a fheidhmiú. D'aontaigh an Roinn Iompair, Turasóireachta agus Spóirt gur chóir do CPC 2,255,633 scair ainmniúil a eisiúint ag costas de €1.25 an ceann, rud a thugann luach de €2,819,542 don Aire Iompair, Turasóireachta & Spóirt le haistriú sócmhainní Chuain Bhá Bheanntraí a chríochnú go Clár Comhardaithe Chuideachta Phort Chorcaí ag 1 Eanáir 2014. Baineadh amach críochnú chónascadh agus chomhdhlúthú shócmhainní agus shocruithe Píolótaíochta Chuain Bhá Bheanntraí go Port Chorcaí le linn chéad leath 2014.

### **Cuspóirí láithreacha Chuideachta Phort Chorcaí Teoranta:**

I gcéad leath 2014, d'ullmhaigh CPCB Plean Gnó do na blianta 2014-2016, agus comhaontaíodh na cuspóirí láithreacha seo a leanas:

- Gach gnáthamh, córas agus rialú riachtanach a chur i bhfeidhm, lena n-áirítear Sláinte & Sábháilteacht, Slándáil, Gnáthaimh Rialaithe Airgeadais Inmheánaigh agus Cúrsaí Timpeallachta;
- Gnó, trádáil agus tréchur cúrsála Chuideachta an Phoirt a fhorbairt agus a fheabhsú;
- Cinntíú go gcloíonn Cuideachta an Phoirt le gach ceist rialála, lena n-áirítear ceisteanna iniúchta, rialachais chorparáidigh agus bainistithe riosca;
- Go mbeadh i bhfeidhm na háiseanna agus an gléasra iomchuí chun riachtanais na gcustaiméirí reatha agus na n-ábhar custaiméara a sheirbhísíú;
- Leanúint orthu de bheith ag cur chun cinn fóillíocht agus turasóireacht mhuirí, agus tacú le tionscainmh ábhartha phobail i mbÁ Bheanntraí; agus
- Céim 1 d'oibreacha feabhas agus caipítíl an chuain laistigh a chur chun tosaigh, faoi mar a beartaíodh agus mar a pléadh iad leis an Roinn Iompair, Turasóireachta & Spóirt.

### **Malartú Talún ÚFT (an tÚdarás Forbartha Tionscail):**

Mar chuid de thionscadal IMERC ag Rinn an Scidígh tá Cuideachta Phort Chorcaí tiomanta d'aistriú tailte atá faoina smacht, i gcomaoín ar thailte ÚFT, chuit Coláiste na hOllscoile, Corcaigh, le Saotharlann nua Hiodrálach agus Lárionad Taighde Mhuirí a thógáil, ag ionchorprú Lárionad Taighde Mhuirí Chorcaí. Leithdháileadh maoliniú Rialtais don tionscadal do COC agus tá an cead pleánála riachtanach faigthe ag COC.

Cuireadh i gcrích aistriú 1.3 heicteár de thailte Chuideachta Phort Chorcaí ar son 3.2207 heicteár de thailte UFT a raibh an luach céanna ag baint leo, le linn 2014. D'eisigh Cuideachta Phort Chorcaí ceadúnas do COC, agus iad ag fanacht leis an dara malartú talún le ÚFT, don dara limistéar talún do chuspóir thógáil bóthair sheirbhísí gaolmhara faoi thalamh.

### **Pointe Marino:**

Tá láithreán Phointe Marino aitheanta le fada an lá mar láithreán oiriúnach Poirt le háiseanna Rinn an Scidígh a chomhlánú. Tá na buanna seo ag baint leis an láithreán:

- Naschacht iarnróid;
- Tá Cé ann cheana féin – tarraigte 10m – Rochtain agus Beartlann; agus
- Ainmniú Seveso ar an láithreán – leis sin, deis atá ann athlónnú láithreán eile Seveso a éascú ó Ché Tivoli agus ó Ché na Cathrach; agus
- Acmhainn shuntasach fhorbartha mar láithreán de chuid Chuideachta Phort Chorcaí

Baineann roinnt ábhar dúshláin leis an láithreán freisin, áfach, i dtaca le pleánail, comhthoil cheadúnais, rochtain droichid agus bhóthair agus costas na hathfhorbartha.

I 2014 d'fhoinsigh Cuideachta Phort Chorcaí compháirtithe a thoiligh láithreán Phointe Marino a fháil agus a fhorbairt in éineacht le Cuideachta Phort Chorcaí, agus leas 20% acu sa Chomhfhiontar seo, faoi réir ag faomhadh an Aire. I Mí na Nollag, 2014, d'iarr Cuideachta Phort Chorcaí faomhadh an Aire chun 20% de Scairchaipiteal Cuideachta CF a fháil le Pointe Marino a cheannach, tar éis cás gnó agus anailíse airgeadais a chur isteach a léirigh go gcloíonn an tionscadal le Treoirlínne na Roinne Airgeadais agus leis an riachtanas dlíthiúil go mbeadh baint ag Cuideachta Phort Chorcaí le CF mar Scairshealbhóir 20%. Tá an tAire ag déanamh breithnithe faoin iarratas seo agus táthar ag fanacht le freagra foirmeálta.

### **Forbairt Cheantar Dugaí Chathair Chorcaí:**

Tacaíonn Cuideachta Phort Chorcaí i gcónaí le hathfhorbairt Cheantar Dugaí Chorcaí agus tá sé i gceist aici ról iomlán a chur i gcrích le cinntí go mbaintear amach poitéinseal an cheantair.

### **Cúrsaí Turasóireachta:**

Téann an Cóbh lámh i lámh le cuid mhór de stair an Chuain agus inniu is féidir leis an mbaile a mhaíomh gur ansin atá suite an t-aon chríochfort tiomnaithe Cúrsála atá le fáil in Éirinn. Faoi láthair is féidir freastal a dhéanamh ar shoithí suas go 340m ar fad. I 2014 thug 58 línéir cúrsála le holltonnáiste de 3.5 milliún tona breis is 120,000 paisinéir agus criú leo chuig an réigiún agus i mbliana, 2015, tá 54 línéir cúrsála le holltonnáiste de 4 mhilliún tona sceidealaithe le cuairt a thabhairt, agus líon paisinéirí agus criú den chineál céanna ag baint leo. Deonadh toiliú pleanála ag Comhairle Chontae Chorcaí ar 22 Nollaig 2014 do chéad chéim na hathfhorbartha ag críochfort Cúrsála Domhainuisce an Chóibh. Cuirfidh an athfhorbairt seo dóthain infrastruchtúir fheistithe agus doimhneachta uisce ar fáil chun cóiríocht a thabhairt do shoithí cúrsála Aicme Quantum (350m ar fad) ag an gcríochfort reatha cúrsála ag úsáid áiseanna bearta ar ann dóibh cheana.

Agus iad curtha le chéile is deis shuaithinseach turasóireachta iad Dúnfoirt Inis Píc, Dúnfort an Chóibh / Titanic / Lusitania agus Dúnfort an Chuain don réigiún. Tá an Port rannpháirteach go gníomhach sna tionscadail seo agus creideann sé go gcomhlánaíonn an taithí nua a thairiscíonn siad an trácht Cúrsála. Tionólfar Searmanas Comórtha an Lusitania “Ag Cuimhneamh ar an Lusitania” ar 7 Bealtaine 2015 sa Chóibh agus tá sé beartaithe go mbeidh an tUachtarán, Michael D. Higgins, i láthair. Tá imscrúdú á dhéanamh ar phointí breise rochtana trasna an Chuain.

Bunaíodh Cuideachta Fhorbartha Mhuirí an Chóibh Teoranta i Mí Mhárta 2013 mar “aonán sainchuspóra”, agus tá Comhairle Contae Chorcaí, Comhairle Cathrach Chorcaí, Comhairle Ceantair Uirbigh an Chóibh agus Cuideachta Phort Chorcaí páirteach ann. Is é an t-aon chuspóir atá ag an aonán seo ná ceantar a fhorbairt i Stáisiún Traenach an Chóibh chun áiseanna agus cóiríocht taispeántais bhreise a thairiscint do thurasóirí agus do phaisinéirí cúrsála.

### **Straitéis Fóillíochta agus Áineasa:**

Agus í ag forbairt Straitéise Fóillíochta agus Áineasa do Chuan Chorcaí, tá roinnt tionscnamh aitheanta ag an gCuideachta le hearnáil an áineasa mhuirí a fhorbairt tuilleadh, ag cuidíú agus ag tacú ar an tstí sin le foinse thábhachtach shuilt agus ghnóthachain eacnamaíoch do chónaitheoirí na háite agus do chuaireoirí araon.

Tá Muiríne Phort Chathair Chorcaí tar éis léiriú go gcuireann sé go mór le Cathair Chorcaí agus tá sí á húsáid go forleathan ag báid áitiúla agus ag báid atá ar cuairt. Éascaíonn an Mhuiríne imeachtaí éagsúla, lena n-áirítear Lá Oscailte Chuan Chorcaí, ‘Ocean to City’ agus an Rás ón gCóbh chuig an Dúcharraig. Leanann an Chuideachta uirthi, trí mheán a Polasaí Freagrachta Corporáidí Sóisialta, de bheith rannpháirteach ar bhealach forleathan le gach páirtí leasmhar de chuid an Phoirt agus le Grúpaí Pobail an Chuain, na forbairtí le déanaí ag Baile an Mhanaigh agus ag Áth Fhada san áireamh.

Tá Cuideachta Phort Bhá Bheanntraí Teo. ag pleannáil chun Taispeántas Ealaíne Muirí a eagrú i dTeach Bheanntraí i samhradh 2015, agus é i gceist tacú le cúrsaí fóillíochta, áineasa agus turasóireachta na háite.

## **Ag forbairt phoitéinseal Turasóireachta:**

Is rannpháirtithe gníomhacha iad Port Chorcaí agus Port Bheanntraí i dtionscnaimh éagsúla ar aidhm leo poitéinseal turasóireachta Chuain Chorcaí agus Chuain Bheanntraí a forbairt. Airítear orthu seo bheith rannpháirteach i ngrúpa oibre Oileán Píce Chomhairle Contae Chorcaí, Grúpa Bainistithe Chuain Chorcaí, bheith ag obair le Comhlachas Tráchtala an Chóibh agus a Chuain, le Fóram Úsáideoirí Bhá Bheanntraí agus le Cumann Oileáin Fhaoidé.

Is í tuairim na Cuideachta gurb ann do phoitéinseal suntasach i dtaca le deiseanna turasóireachta tráchtala sna Cuain, a thacódh le fás an turais sheanbhunaithe chúrsála agus gnólachtaí eile ó réimse na turasóireachta. Is féidir le léiriú stair shaibhir mhuirí, imirce agus thrádála Chuain Chorcaí agus Chuain Bheanntraí, le himeacht ama, deiseanna gnó agus fostáiochta inbhuanaithe a ghiniúint. Tá sé de rún ag an gCuideachta príomhról a chur i gcrích sa réimse seo, trí forbairt a cuid gnó agus trí thacú le forbairt eacnamaíoch agus le poitéinseal fostáiochta an réigiúin seo.

## **Easnamh Chiste Phinsin le Sochar Sainithe:**

Feidhmíonn Cuideachta Phort Chorcaí scéimeanna pinsin le sochar sainithe d'fhostaithe a thosaigh ag obair leis an gComhlacht roimh 6 Márta 2006. I gcás na bhfostaithe a earcaíodh i ndiaidh 6 Márta 2006, feidhmíonn an Chuideachta scéim Phinsin le Ranníocaíocht Shainithe.

Tá sonraí le fáil i dtaca le Scéimeanna Pinsin Chuideachta-Luacháil Achtúireach agus Faisnéisithe FRS17 i nota 26 do na Ráitis Airgeadais bhliantúla atá ceangailte leis seo.

## **Tosaíochtaí Láithreacha:**

Seo a leanas tosaíochtaí láithreacha Chuideachta Phort Chorcaí:

- Leanúint ar aghaidh le fás ag Port Chorcaí agus ag Port Bheanntraí trí iomaíocht, infheistiú agus brabúsacht athnuaithe don fhadtéarma agus trí chaidreamh leanúnach lenár gcuid custaiméirí ar fad;

Mar fhocal scoir, ba mhaith liom mo bhruíochas a ghabháil le mo chuid comhStiúrthóirí, as a gcuid tiomantais agus as an spéis a léirigh siad i ngnóthaí na cuideachta in éineacht lena gcuid tacaíochta dílse agus lena ndíograis maidir le bheith ag freastal ar chruinnithe boird, coiste, fochuideachta, iontaobhaithe agus ar imeachtaí eile de chuid na cuideachta.

## **Chief Executive's Report**

The Port of Cork Company returned a significantly improved performance in 2014 compared to 2013. On the 1<sup>st</sup> January 2014, the Port of Cork Company amalgamated with Bantry Bay Harbour and the combined traffic of both Ports amounted to 10.15 million tonnes. Turnover in 2014 amounted to €24.8 million up from €23.3 million in 2013. Profit after Taxation for the Financial Year amounted to €2.5 million compared to €1.7 million in 2013, an increase of €0.8 million or 50% approximately.

In 2014, the Company maintained its on-going commitment to Capital Investment by making additions to Fixed Assets of €8 million. This brings investment levels by the Company, since incorporation in 1997, to €117 million. Most noticeable, in May 2014 the Company lodged an application for Planning Consent for new Port Infrastructure in Ringaskiddy with An Bord Pleanála, under the terms of the Planning and Development (Strategic Infrastructure) Act 2006. The associated Oral Hearing took place in September 2014 and a decision by An Bord Pleanala is anticipated before the end of May 2015.

Following the decision by the Minister for Transport, Tourism and Sport, Bantry Bay Harbour Commissioners assets and trade were transferred to the Port of Cork Company effective from 1<sup>st</sup> January 2014. Bantry Bay Port Company Limited, a 100% subsidiary of the Port of Cork Company, was established and this Company now manages Bantry Bay Harbour.

### **The Economic Challenge**

Irish Ports have a critical role in supporting the current recovery in the Irish Economy. This recovery however is dependent on our ability to trade successfully. To sustain this economic recovery Ireland's small open economy is likely to have an even greater dependence on external trade and on Ports such as the Port of Cork.

The Government has stated that it expects the Port of Cork Company as one of three Tier 1 Ports of National Significance, to lead the response of the State Commercial Port Sector in the delivery of future National Port capacity. This requires that we develop to our full potential. The Port of Cork is intent on growing its' business and to continue to improve levels of competitiveness in the Port. Equally, the Port is intent on ensuring that it delivers prosperity to the Nation and the Munster Region in particular by developing and becoming a significant International Trade Gateway and an important node in the Global Supply Chain Network.

The Port of Cork being Irelands' premier Deepwater Port on the South Coast must have Port infrastructure with the capacity to handle ships which continue to grow in size. The lack of adequate Port infrastructure capacity into the future in the Port of Cork will have the effect of undermining the competitiveness of Irish businesses and this in turn will undermine the regions ability to participate in and benefit from valuable global trading opportunities, and economic growth.

### **Strategic Planning of Port Infrastructure**

Consistent with the Port of Cork Strategic Development Plan, the Port of Cork Company continued to plan for the delivery of new Port infrastructure in the lower harbour. The Company's Strategic Development Plan which is endorsed by the Government in the National Ports Policy Statement also has EU recognition by the designation as an EU Core Port. The Company was successful with its EU TEN-T Funding Application to obtain statutory consents for Ringaskiddy developments.

The Company with the endorsement of its proposals is confident that with the necessary Planning Consent it will be able to proceed to deliver infrastructure proposals and will continue to make a significant contribution towards the economic development of the Irish economy.

## **The Competitive Challenge**

The ongoing challenge of maintaining business and profitability levels on a credible scale in 2014 required sustained and vigorous efforts across a number of fronts. The ongoing viability of the company requires that the rigorous regime of cost control across all activities is maintained.

Cork Port Terminals Services Ltd, a subsidiary of the Port of Cork Company continues to demonstrate an ability to successfully and profitably operate LoLo and RoRo stevedoring services in the Port. All loans associated with the 2009 Docks rationalisation were finally paid off in September 2014. The Company's ongoing commitment to the achievement of improved levels of flexibility and responsiveness to customers contributes on an ongoing basis to sustaining trade and to building a solid foundation for business growth.

## **Port of Cork Business Plan**

The Port of Cork Corporate Business Plan 2015 – 2019 was approved by the Board of Directors in December 2014. This plan provides a structured framework and context for the development of the Ports customer base, operating processes and human, physical and financial resources. It sets out challenging targets to be met and standards to be achieved. It also addresses key challenges such as the achievement of profitable business growth, the advancement of the Capital Development Programme and a continued development of quality facilities and efficient response of services to our customers.

## **Environment**

Sustaining the quality of the environment in Cork Harbour, particularly in areas which have the potential to be affected or influenced by Port Operations remains a priority for the Company. We are committed to the highest standards of environmental management through the implementation of our environmental management programme operated to global best practices and standards consistent with the renewed ISO14001 and Eco Ports foundation accreditation.

## **Corporate Social Responsibility**

The Port of Cork Company Corporate Social Responsibility (CSR) policy aims to align the Company's values and behaviour with the expectations and needs of its stakeholders and the community. This CSR Policy commits the Company to:

- engaging with stakeholders,
- complying with all legislation including Health & Safety and Environmental legislation,
- enhancing our international reputation as a unique natural harbour available for sustainable development,
- providing best practice labour standards and employee welfare, and
- embracing new technologies and management systems to minimise the Port of Cork's carbon footprint.

During 2014, the Company continued to be involved in a number of local community based projects in Cork Harbour. The Port of Cork City Marina continues to be a major addition to the high quality facilities already in existence such as, the Millennium Garden in Tivoli, the Pier in Crosshaven and the landscaping at Ringaskiddy. A new playground was developed on port lands in Ringaskiddy and opened in May 2015. The Port's Strategic Development Plan proposes further significant improvements to the Ringaskiddy Amenity areas. The Company has also

continued to work in partnership with the National Maritime College of Ireland in providing training for Port and Harbour related activities. It is intended that this area of activity will be expanded in future years.

The Port of Cork Primary Schools Initiative, now in existence for ten years, continues to grow and be more successful in raising awareness levels of the Port among school children in Cork. The 2015 schools initiative was the most successful to date themed ‘RMS Lusitania – Commemorating 100 Years’ and recently concluded with a record number of projects submitted from 32 schools around Cork Harbour, City and County.

### **‘Cork Mega Port’**

Goldhawk Media approached the Port of Cork after being commissioned by TV3 to make a Series on the Port of Cork called ‘Cork Mega Port’. The ‘fly on the wall’ style series consists of four one hour episodes and aired during 2014 on TV3. The episodes were both positive and uplifting, while at the same time entertaining and informative, showing all aspects of the Port of Cork. ‘Cork Mega Port’ has been received positively by viewers with many people taking to social media to express their interest and views on the programme. Series 2 of Cork Mega Port is now due to be aired later in 2015 on TV3.

### **Tourism**

In 2014, the Company hosted 53 cruise ships, carrying in excess of 120,000 passengers and crew to the Port of Cork making a very significant contribution to the economy of the region. The Port of Cork Company’s continued commitment to the cruise business is reinforced by a Board decision to invest a further €1.6m at the dedicated cruise facilities at the Cobh Cruise Terminal, the purpose of which is to accommodate the latest Quantum Class Cruise Ships. Brittany Ferries continues to operate very successfully their weekly service between Cork and Roscoff.

### **Employees**

The Port of Cork Company is committed to developing and harnessing the skills and knowledge of its employees in the achievement of Company goals. Specific actions are being taken to improve communications, industrial relations and employee development and management systems. Training and development continues to be proactive in response to the ever improving customer orientated services within the company.

### **Safety, Health and Welfare**

With the support of all employees the Company operates a rigorous health and safety regime. This policy is based on the requirements of employment legislation and health and safety standards, including the requirements contained in the Safety, Health and Welfare at Work Acts. The achievement of the Health & Safety OHSAS 18001 accreditation has made the Company improve awareness levels throughout the Port. This standard is recognised as the international benchmark for best practice in Occupational Health & Safety and was awarded in recognition of the high standards of safety practice and awareness in the Port of Cork.

The Company has a strong view that all operations of the Port must be safe as well as efficient. During 2014, the Health and Safety Awareness Campaign continued and all employees received safety awareness training. The Company also has an Employee Well Being programme which includes a comprehensive Employee Assistance Programme, biennial voluntary health screenings and education awareness programmes.

## **Operational Risk Management – International Code for Safety and Environmental Management in Ports (IPSEM)**

The Port of Cork Company certificate of compliance under the IPSEM code by the international organisation Bureau Veritas was reconfirmed in 2014. IPSEM is a code of practice and certification scheme which covers safety and environmental management of operations and maintenance of all port facilities. It provides the Company with a powerful tool to improve port operating systems, safety and environmental protection.

### **Strategic Risk Management**

During 2014 the Port of Cork Company updated its strategic risk management assessment and based on this analysis, the key risks facing the Company were identified. Strategic Risk Management continues to be a priority in the management and development of the Port of Cork Company. In addition to regular external and internal audit reviews, the company is committed to health and safety, environmental, IPSEM, Port Security and other accreditations. The company continually reviews procedures to ensure that robust management processes are in place for the management and control of risk.

### **Acknowledgements**

With the direction and support of the Board and the continued commitment, dedication and professionalism of the staff, the Port of Cork Company is committed to meeting the many challenges it faces in the future and to providing an excellent service to our customers.

I wish to thank the Chairman Mr. John Mullins and all the Directors for their support and guidance. ## Tuarascáil an Phríomhfheidhmeannaigh

Chuir Cuideachta Phort Chorcaí feidhmíocht a bhí feabhsaithe go suntasach i gcrích i 2014 le hais 2013. Ar 1 Eanáir 2014, cónascadh Cuideachta Phort Chorcaí le Cuan Bhá Bheanntraí agus ba é an trácht a bhí ag an dá Phort le chéile ná 10.15 milliún tona. Ba é an láimhdeachas a bhí i gceist i 2014 ná €24.8 milliún suas ó €23.3 milliún i 2013. Bhí an brabús tar éis Cánachais don Bliaín Airgeadais ag €2.5 milliún i gcomparáid le €1.7 milliún i 2013, sin méadú ar €0.8 milliún nó thart ar 50%.

I 2014 lean an Chuideachta ar aghaidh lena tiomantas don Infheistíocht Chaipítel trí mhéideanna breise a chur lena cuid Acmhainní Seasta ar luach €8 milliún. Tugann sin leibhéal infheistíochta ag an gCuideachta, óna corprú i 1997, go €117 milliún. An rud is suntasaí a tharla, ná gur lóisteáil an Chuideachta iarratas ar Thoiliú Pleanála d'Infrastruchtúr nua Poirt i Rinn an Scidígh leis an mBord Pleanála, faoi théarmaí an Achta um Phleanáil agus Forbairt (Infrastruchtúr Straitéisearch) 2006. Tharla an Éisteacht ghaolmhar ó Bhéal i Mí Mheán Fómhair 2014, agus táthar ag súil le socrú ón mBord Pleanála roimh dheireadh Mhí na Bealtaine 2015.

Tar éis an tsocraithe a rinneadh ag an Aire Iompair, Turasóireachta agus Spóirt, aistríodh sócmhainní agus trádáil Choimisinéirí Cuain Bhá Bheanntraí go Cuideachta Phort Chorcaí le feidhm ó 1 Eanáir 2014. Bunaíodh Cuideachta Phort Bhá Bheanntraí Teoranta, atá 100% faoi úinéireacht Chuideachta Phort Chorcaí, agus is í an Chuideachta seo a bhainistíonn Cuan Bhá Bheanntraí anois.

### An Dúshlán Eacnamaíoch

Tá ról ríthábhachtach le cur i gcrích ag Poirt na hÉireann maidir le tacú le téarnamh reatha Gheilleagar na hÉireann. Tá an téarnamh seo ag brath, áfach, ar ár gcumas bheith ag trádáil go rafar. Chun an téarnamh eacnamaíoch seo a chothabháil is dócha go mbeidh geilleagar beag oscailte na hÉireann ag brath níos mó ná riamh ar thrádáil sheachtrach agus ar Phoirt mar Port Chorcaí.

Tá ráite ag an Rialtas go bhfuil siad ag súil leis go mbeidh Cuideachta Phort Chorcaí, mar cheann de thrí cinn de phoirt Leibhéal 1 Suntasachta Náisiúnta, i gceannas ar fhreagra Earnáil Phoirt Tráchtála an Stáit maidir le seachadadh thoilleadh na bPort Náisiúnta sa todhchaí. Éilíonn sin go mbeimis ag forbairt an méid a bhfuilimid in ann. Tá Port Chorcaí leagtha ar fhás a chuid gnó agus chuige sin, leanfaidh sé air de bheith ag feabhsú leibhéal iomaíochta sa phort. Ar an tslí chéanna, tá an port leagtha ar chinntí go seachadann sé rachmas don Náisiún agus do Réigiún na Mumhan go háirithe, trí Thairseach shuntasach Idirnáisiúnta Trádála a fhorbairt agus trí bheith ina phointe tábhachtach i Líonra an tSlabhra Sholáthair Dhomhanda.

Is é Port Chorcaí chéad Phort domhainmhara na hÉireann ar an gCósta Theas agus ní mór, mar sin de, go mbeadh infrastruchtúr Poirt aige a bhfuil d'acmhainn aige longa a láimhseáil, longa a bhíonn de shíor ag éirí níos mó. Beidh de thoradh ar easpa thoilleadh sásúil infrastruchtúir phoirt sa todhchaí i bPort Chorcaí an bonn a bhaint d'iomaíocht ghnólachtaí na hÉireann, agus lena sheal bainfidh sin an bonn de chumas an réigiúin bheith páirteach i ndeiseanna luachmhara domhanda trádála agus leas a bhaint astu.

### Pleanáil Straitéisearch Infrastruchtúr an Phoirt

Comhsheasmhach le Plean Forbartha Straitéisearch Phort Chorcaí, lean Port Chorcaí air de bheith ag pleanáil do sheachadadh infrastruchtúir nua Poirt sa chuan íochtarach. Tacaíodh le Plean Forbartha Straitéisí na Cuideachta ag an Rialtas i Ráiteas Polasaí na bPort Náisiúnta agus tá aitheantas ag an bPlean ón AE freisin trína ainmniú mar Phort Croí-líonra de chuid an AE. D'éirigh le hiarratas na Cuideachta ar mhaoiniú TEN-T AE le comhthoilithe reachtúla a fháil d'fhorbairtí i Rinn an Scidígh.

Tar éis tacaíochta a fháil dá cuid tograí, tá an Chuideachta muiníneach, leis an Toiliú Pleanála riachtanach, go mbeidh sí ábalta dul ar aghaidh chun tograí infrastruchtúir a sheachadadh agus leanfaidh sí uirthi de bheith ag cur go suntasach le forbairt eacnamaíoch gheilleagar na hÉireann.

## An Dúshlán Iomaíoch

I dtaca leis an dúshlán leanúnach de bheith ag cothabháil leibhéil ghnó agus bhrabúsachta ag scála inchreidte i 2014, theastaigh iarrachtaí marthanacha agus bríomhara ar fud roinnt frontaí. Éilíonn immharthanacht leanúnach na cuideachta go ndéanfaí dianréimeas an rialaithe chostais ar fud gach gníomhaíochta a chothabháil.

Leanann Seirbhísí Críochfoirt Phort Chorcaí, fochuideachta de chuid Chuideachta Phort Chorcaí, orthu de bheith ag léiriú cumais seirbhísí stíbheadóireachta LoLo agus RoRo a fheidhmiú go rafar agus go brabúsach sa Phort. Íocadh gach iasachta bhain le réasúnú 2009 na nDuganna i Mí Mheán Fómhair 2014 sa deireadh thiar thall. Cuireann tiomantas leanúnach na Cuideachta do bhaint amach leibhéal feabhsaithe solúbthachta agus freagrúlachta do chustaiméirí, cuireann sin ar bhonn leanúnach le hinbhuanú na trádála agus le tógáil bunsraithe dlúthbhoinn d'fhás an ghnó.

## Plean Gnó Phort Chorcaí

Faomhadh Plean Gnó Chorparáidigh Chuideachta Phort Chorcaí 2015 – 2019 ag Bord na Stiúrthóirí i Mí na Nollag 2014. Soláthraíonn an pleán seo creatlach agus comhthéacs struchtúrtha d'fhorbairt bhonn custaiméirí, do phróisis oibriúcháin agus d'acmhainní daonna, fisiciúla agus airgeadais an Phoirt. Leagtar amach ann spriocanna dúshlánacha atá le cur i gcrích agus caighdeáin atá le baint amach. Tugtar aghaidh ann freisin ar phríomhdhúshláin, leithéidí baint amach fáis ghnó atá brabúsach, cur chun cinn an Chláir um Fhorbairt Chaipitil agus forbairt leanúnach áiseanna d'ardchaighdeán agus freagra éifeachtach ar sheirbhísí d'ár gcustaiméirí.

## An Timpeallacht

Is tosaíocht don Chuideachta é caighdeán thimpeallacht Phoirt Chorcaí a inbhuanú, go háirithe sna réimsí sin arbh fhéidir go rachadh Oibriúcháin an Phoirt i bhfeidhm orthu. Táimid tiomanta do na caighdeáin is airde bainistithe thimpeallachta trí chur i bhfeidhm ár gcláir bhainistithe thimpeallachta agus é ag feidhmiú de réir na gcleachtas domhanda is fearr agus de réir caighdeán atá comhsheasmhach leis an ISO14001 athnuaithe agus le creidiúnú boinn EcoPorts.

## Freagracht Shóisialta Chorparáideach

Tá sé d'aidhm ag polasaí Freagrachta Sóisialta Corparáidí (FSC) Chuideachta Phort Chorcaí luachanna agus iompar na cuideachta a chur ar comhréim le hionchais agus le riachtanais a cuid páirtithe leasmhara agus an phobail. Leis an bPolasaí FSC seo tá an chuideachta tiomanta:

- don idirghníomhú leis na páirtithe leasmhara,
- do chomhlíonadh na reachtaíochta ar fad, lena n-áirítear reachtaíocht faoi Shláinte agus faoi Shábháilteacht agus reachtaíocht a bhaineann leis an timpeallacht,
- d'fheabhsú ár gclú idirnáisiúnta mar chuan nádúrtha suaithinseach atá ar fáil don fhorbairt inbhuanaithe,
- do sholáthar chaighdeáin saothair agus leas na bhfostaithe a chloíonn leis an gcleachtas is fearr, agus
- do bheith ag glacadh le teicneolaíochtaí agus le córais bhainistithe nua le lorg carbóin Phort Chorcaí a laghdú.

Le linn 2014 lean an Chuideachta uirthi de bheith páirteach i roinnt tionscadal áitiúil bunaithe ar an bpobal i bPort Chorcaí. Leanann Muiríne nua Phort Chathair Chorcaí uirthi de bheith ag cur go mór leis na háiseanna d'ardchaighdeán atá le fáil cheana féin, leithéidí Gairdín na Mílaoise i dTivoli, an Ché ag Bun an Tábhairne agus an tírdhreachú ag Rinn an Scidígh. Forbraíodh clós súgartha nua ar thailte poirt i Rinn an Scidígh agus osclaíodh é i Mí na Bealtaine 2015. Molann Plean Forbartha Straitéiseach an Phoirt feabhsúcháin shuntasacha bhreise do limistéir Fóntais Rinn an Scidígh. Lean an chuideachta uirthi de bheith ag obair i gcomhar le Coláiste Náisiúnta Muirí na hÉireann le hoiliúint a sholáthar do ghníomhaíochtaí a bhaineann leis an bPort agus leis an gCuan. Tá sé i gceist go leathnófaí an réimse gníomhaíochta seo sna blianta atá amach romhainn.

Tá Tionscnamh Bunscoileanna Phort Chorcaí, ar ann dó le deich mblianaanois, ag leanúint air de bheith ag fás agus tá sé níos rafaire ná riamh maidir le leibhéal fheasachta a spreagadh faoin bPort i measc leanaí scoile Chorcaí. D'éirigh níos fearr ná riamh le tionscnamh scoile 2015, leis an téama 'RMS Lusitania – Comóradh 100 bliain' agus cuireadh deireadh leis le déanaí leis an líon is mó riamh de thionscadail a cuireadh isteach ó 32 scoil thart ar Chuan, ar Chathair agus ar Chontae Chorcaí.

### **'Cork Mega Port'**

Rinne Goldhawk Media teagmháil le Port Chorcaí, tar éis do TV3 iad a choimisiúnú le sraith chlár a dhéanamh faoi Phort Chorcaí, dar teideal 'Cork Mega Port'. Bhí i gceist leis an tsraith 'ar an láthair' seo ceithre eipeasóid uair an chloig a craoladh le linn 2014 ar TV3. Bhí na cláir dearfach agus tógáil croí a bhí iontu, agus ag an am céanna bhí siad idir shiamsúil agus fhaisnéiseach, iad ag léiriú gach gné de Phort Chorcaí. Chuir an lucht féachana fáilte roimh 'Cork Mega Port' agus bhain a lán daoine úsáid as na meáin shóisialta lena spéis sa chlár a léiriú agus lena gcuid tuairimí faoi a chur in iúl. Tá an dara sraith de 'Cork Mega Port' le craoladh níos déanaí i 2015 ar TV3.

### **An Turasóireacht**

I 2014 d'óstáil an chuideachta 53 long chúrsála, iad ag iompar breis is 120,000 paisinéir agus criú go Port Chorcaí; chuir sin go suntasach le geilleagar an réigiúin. Treisítear le tiomantas leanúnach Chuideachta Phort Chorcaí le gnólacht na cúrsála ag socrú de chuid an Bhoird €1.6m breise a infheistiú ag na háiseanna tiomnaithe cúrsála ag Críochfort Cúrsála an Chóibh, infheistíocht a bhfuil sé mar aidhm aici freastal a dhéanamh ar na Longa Cúrsála is nua Aicme Quantum. Leanann Brittany Ferries orthu de bheith ag feidhmiú go han-rafar a seirbhís sheachtainiúil idir Corcaigh agus Roscoff.

### **Fostaithe**

Tá cuideachta Phort Chorcaí tiomanta d'fhorbairt agus d'úsáid scileanna agus eolas a cuid fostaithe le cuspóirí na Cuideachta a bhaint amach. Tá gníomhartha sonracha á gcur i gcrích le feabhas a chur ar chumarsáídí, ar chaidrimh thionsclaíocha agus ar fhorbairt na bhfostaithe agus na gcóras bainistithe. Leanann an oiliúint agus an fhorbairt orthu de bheith onnghníomhach maidir le freagra a thabhairt ar na seirbhísí custaiméara laistigh den chuideachta, a mbítear ag cur feabhais orthu i rith an ama.

### **Sábháilteacht, Sláinte agus Leas**

Le tacáiocht na bhfostaithe ar fad feidhmíonn an Comhlacht dianréimeas sláinte agus sábháilteachta. Tá an polasaí seo bunaithe ar riachtanais na reachtaíochta fostaithe agus na gcaighdeán sláinte agus sábháilteachta, lena n-áirítear na riachtanais atá le fáil sna hAchtanna um Shábháilteachta, Sláinte agus Leas san Obair. Nuair a bhain muid

amach creidiúnú Sláinte & Sábháilteachta OHSAS 18001 spreagadh an Chuideachta le leibhéal fheasachta a fheabhsú ar fud an Phoirt. Aithnítear an caighdeán seo mar an tagarmharc idirnáisiúnta don chleachtas is fearr i réimse Shláinte & Shábháilteachta na Ceirde agus comhartha aitheantaí atá ann de na caighdeáin is airde cleachtais agus fheasachta sábháilteachta i bPort Chorcaí.

Creideann an Chuideachta go láidir nach mór do gach oibriúchán sa Phort a bheith sábháilte chomh maith le bheith éifeachtach. Le linn 2014, leanadh ar aghaidh leis an bhFeachtas Feasachta Shláinte agus Shábháilteachta agus fuair gach fostáí oiliúint fheasachta sábháilteachta. Tá Clár Leasa Fhostaithe ag an gCuideachta freisin a chuimsíonn Clár cuimsitheach Cabhrach don Fhostaí, scagáil sláinte dhébhliantúil dheonach agus cláir fheasachta oideachais.

### **Bainistiú Riosca Oibríochtúil – an Cód Idirnáisiúnta do Bhainistiú na Sábháilteachta agus na Timpeallachta sna Poirt (IPSEM)**

The directors present their annual report and the audited consolidated financial statements of the group for the year ended 31 December 2014.

### **Principal Activities**

The company is committed to providing, on a sound commercial basis, safe, efficient and cost effective Port facilities, services, accommodation and lands in its harbour which meet the needs of its customers.

### **Results and Dividends**

In response to a request from the shareholder for the payment of a dividend the Board of Directors of the Port of Cork Company recommends the payment of a dividend in the amount of 26% of profit after tax.

### **Review of the Business**

Details of the Profit for the year, together with comparative figures for 2013 are set out in the Consolidated Profit and Loss Account on Page 11 and the related notes.

Throughput amounted to 10.14 million tonnes in 2014 (9.12 million tonnes in 2013).

Total revenue for 2014 amounted to €24.8 million, a 6.42% increase on 2013 (€23.3 million). Operating profit increased by 45% to €2.68 million from €1.85 million in 2013. There was a profit on Ordinary Activities before Taxation of €2.72 million in 2014 compared with €1.74 million in 2013 an increase of 57%. On 1st January 2014, Bantry Bay Harbour Commissioners activities, assets and trade were transferred to the Port of Cork Company. A subsidiary company, Bantry Bay Port Company Limited was established to manage the activities of Bantry Harbour.

### **Port of Cork Company Pension Schemes-Actuarial Valuation**

The Port of Cork Company operates defined benefit pension schemes. The latest full actuarial valuation of the Company's Pension Schemes was carried out at 28 February 2014 by Mercer Limited, Actuaries and Consultants, using the minimum funding standard valuation of liabilities. At the date of the actuarial valuation the market value of the assets of the Port of Cork Company Superannuation schemes was €42.35 million and the actuarial valuation showed that the actuarial value of those assets was 83% of the benefits that had accrued to members.

### **FRS 17 "Retirement Benefits"**

The company has adopted Financial Reporting Standard 17 (FRS 17) "Retirement Benefits" in full. This has resulted in a Pension Fund deficit based on the FRS17 assumptions of €11.82 million at 31 December 2014, compared to a deficit of €6.77 million at 31 December 2013. The company, following legal opinion, considers it prudent to provide for the Port of Cork Pilotage Authority Pension Schemes. Consequently, the liability arising has been accounted for at 31 December 2014. The impact of FRS17 is outlined in detail in Note 26 to the Financial Statements.

#### **Future Developments**

The immediate objective of the company is to continue to operate as a commercial state owned company. This is being accomplished by putting in place the correct structures and procedures so as to provide a solid foundation which will:

- (a) ensure continuation of the high safety and regulatory standards of services provided to ships operating in Cork Harbour,
- (b) ensure all proper measures are taken for the management, control, operation and development of its harbour and the approach channels thereto,
- (c) encourage investment in its harbour,
- (d) enable the development of profitable ancillary commercial activities related to core activities,
- (e) ensure that the resources available to the company are utilised and managed in a manner consistent with the objects of the company.

#### **Principal Risks and Uncertainties**

During 2014 the Port of Cork Company carried out a risk assessment. Risks were prioritised using a Total Risk Score (TRS) determined as the product of the impact and likelihood scores. Based on this analysis, the key risks facing the Company were identified.

#### **Key Performance Indicators (KPI's)**

The company is result orientated and prepares an annual budget and corporate business plan for the next five financial years. Actual performance is measured against budget. The main KPI's used by the company to measure performance are revenue, direct expenses, non operational income, departmental overheads, profit before tax and cash flow.

There is also a broad range of KPI's used within the organisation which are broken down by department and responsible person. These KPI's are in turn monitored and reported on to ensure that KPI targets are achieved.

#### **Environmental Matters**

The Port of Cork Company is committed to the highest standards in environmental management programmes and is accredited under ISO14001 and ECOPORTS foundation.

#### **Energy**

The Port of Cork Company is committed to operating to the highest possible energy efficiency standards and is progressing with ISO 50001 Energy Management Standards certification.

The Port of Cork has signed a Partnership agreement with SEAI and reports annually on energy usage and actions to reduce energy consumption in accordance with S.I. 542 of 2009 which obliges public sector organisations to improve energy performance by 33% by 2020.

#### **Shareholders**

Each Committee of the Board operates under specific terms of reference.

The present members of the **Audit & Risk Committee** are Mr. N. Cregan (Chairman), Ms. H. Boyle and Mr. B. Cantwell. The Audit Committee held three meetings during 2014.

The members of the **Remuneration Committee** are Mr. J. Mullins, Mr. D. McEvoy and a Department of Transport Tourism and Sport Representative. The Remuneration Committee members meet to deal with the remuneration and contract of the Chief Executive within Government Guidelines.

The members of the **Investment Committee** are Mr. J. Mullins, Mr. B. Cantwell, Mr. D. Doolan and Mr. P. Mulvihill.

Mr. J. Mullins, Mr. B. Keating and Mr. N. Cregan are **trustees** of the Port of Cork Company Superannuation Fund.

The Financial Statements are prepared on the going-concern basis, as the directors are satisfied that the Port of Cork Company has adequate resources to continue in business for the foreseeable future.

#### **Political Donations**

The company did not make any political donations during the year.

#### **Prompt Payment of Accounts Act, 1997**

It is the company's policy to pay all creditors in accordance with the terms of the Prompt Payment of Accounts Act, 1997. ### **Note**

#### **(1) Statement of Accounting Policies**

The significant accounting policies adopted by the company are as follows:

##### **Basis of Preparation of Financial Statements:**

The financial statements have been prepared in accordance with accounting standards issued by the Financial Reporting Council and Irish statute comprising the Companies Acts, 1963 to 2013.

##### **Accounting Convention:**

The financial statements are prepared under the historical cost convention.

##### **Basis of Consolidation:**

These financial statements consolidate the financial statements of the company and its subsidiaries for the year ended 31 December 2014.

##### **Turnover:**

This comprises revenue from charges to port users and rent of both operational and estate property. Charges to port users are recognised as revenue when the provision of services are completed. Rental income is recognised in the period to which it relates.

##### **Fixed Assets and Depreciation:**

The Fixed Assets of the Cork Harbour Commissioners were revalued on 2 March 1997 after consultation with the Minister for the Marine and Natural Resources. The revalued assets were transferred to the Port of Cork Company on vesting day, 3 March 1997, under the Harbours Act 1996 in consideration for shares issued to the Minister for the Marine and Natural Resources and the Minister for Finance. The valuation of assets was carried out by independent valuation experts, specialist machinery manufacturers and by the company's own professional staff.

The cost of operational fixed assets comprises the purchase price of land, buildings, site developments and roadways, quays and piers, capital dredging, pontoons, cranes, winches, hoists, floating crafts, motor vehicles and other plant and equipment. Historical Cost includes construction and installation expenditure where incurred. It is the policy of the Port of Cork Company to allocate part of the relevant overheads to the cost of capital works.

No provision is made for the depreciation of land. Other operational fixed assets are being depreciated by the straight-line method according to their effective economic lives as follows:

#### **(1) Statement of Accounting Policies (continued)**

##### **Heritage Assets:**

The company has a collection of paintings, which at cost also includes sketches and photographs, which are reported in the Balance Sheet. The paintings are deemed to have indeterminate lives and a high residual value; hence the company does not consider it appropriate to charge depreciation.

##### **Grants and Contributions to Tangible Fixed Asset Costs:**

European Regional Development Fund, European Cohesion Fund and other grants and contributions to tangible fixed asset costs are shown separately on the Balance Sheet as deferred credits, pending transfer to the Profit and Loss Account on the same basis as the relevant assets are depreciated.

##### **Foreign Currency:**

Transactions arising in foreign currencies are translated into Euro at the rates of exchange ruling at the date of the transaction. There were no Monetary Assets or Liabilities denominated in foreign currencies at the year end. All exchange gains or losses are accounted for through the Profit and Loss Account.

##### **Stocks:**

Stores and materials are valued at cost and charged out at that price. Items in stock are written off when held for more than 3 years.

##### **Investments:**

Investments in subsidiary and associated companies are stated at cost less provision for impairment.

Investments in managed funds (liquid assets) are stated at market value.

##### **Leases:**

Where tangible assets are financed by leasing agreements which give rights approximating to ownership ("Finance Leases") they are treated as if they had been purchased outright at the present value of the minimum lease payments and the corresponding leasing liabilities are shown in the balance sheet as finance lease obligations.

Depreciation on leased assets is calculated on a straight line basis over the estimated useful lives of the individual assets. Interest arising on finance leases is charged to the Profit and Loss Account in proportion to the amounts outstanding under the leases.

Payments under operating leases are expended as they accrue over the period of the leases.

##### **Deferred Taxation:**

Deferred Taxation is provided using the liability method on all material timing differences. Provision is made at the rate which is expected to be applied when the liability is expected to crystallise.

##### **Corporation Tax:**

Current tax is provided at amounts expected to be paid (or recovered) using tax rates and laws that have been enacted at the balance sheet date.

**(1)**

**Pension Costs:**

The Port of Cork Company operates defined benefit and defined contribution pension schemes for its employees, the assets of which are held in separate trustee-administered funds. Contributions in respect of regular service costs of providing retirement benefits to employees during the year, together with the costs of any benefits relating to past service are charged to the Profit and Loss Account in accordance with the requirements of FRS 17 under Administration and General Expenditure. The cost of providing benefits and the liabilities of the defined benefit plans are determined using the projected unit method with valuations being carried out at each Balance Sheet date.

A credit representing the expected return on the assets of the pension schemes during the year, based on the market value of the assets of the schemes at the start of the financial year, is included in the Profit and Loss Account under Interest Receivable and Similar Income. A charge representing the expected increase in liabilities of the pension schemes during the year, arising from the liabilities of the schemes being one year closer to payment is also included in the Profit and Loss Account under Interest Receivable and Similar Income.

The difference between the market value of the assets and the present value of accrued pension liabilities is shown as an asset / liability in the Balance Sheet.

Actuarial Gains and Losses are recognised immediately in the Statement of Total Recognised Gains and Losses.

The Defined Contribution Pension Scheme payments are recognised as they fall due and any outstanding amounts at the year end are included as an accrual in the Balance Sheet.

**Revenue Recognition:**

Revenue is recognised when the provision of services to customers has been completed.

**(2) Turnover**

Turnover comprises the invoice value of services supplied by the company exclusive of V.A.T.

The amount of turnover attributable to different activities is not disclosed under the provisions of paragraph 41 (5) of Part IV of the Schedule to the Companies (Amendment) Act 1986.

### **(26) Pension Schemes:**

#### **(a) Actuarial Valuation**

The Company operates defined benefit pension schemes. The latest full actuarial valuation of the Port of Cork Company's Pension Schemes was carried out at 28 February 2014 by Mercer Limited, Actuaries and Consultants, using the minimum funding standard valuation of liabilities. At the date of the actuarial valuation the market value of the assets of the schemes was €42.35 million and the actuarial valuation showed that the actuarial value of those assets was 83% of the benefits that had accrued to members. The contributions for the year amounted to €1,015,078 in accordance with independent professionally qualified actuary advice. The Port of Cork Company made pension payments totalling €2.80m during 2014, on behalf of the Port of Cork Company Superannuation Fund.

The Board of Directors of the Port of Cork Company established a defined contribution pension scheme for new employees with effect from 1 January 2006. The Company paid an amount of €163,272 into this defined contribution pension scheme during 2014 (2013 €140,876) and there was an amount of €20,623 due at year end (2013 €16,810). The defined benefit pension scheme continues for existing members.
