GENERAL PROVISIONS

1. In the above list of charges, the word "day" means any 24 hour period (beginning at midnight and ending at the next midnight) or part thereof.
2. The charges listed are exclusive of labour, except for the Container Cranes, Straddle Carriers, Rubber Tyred Gantries, Tug "Gerry O'Sullivan" and Ringaskiddy Cranes.
3. Where labour is directly employed in the hire of the plant, the cost of labour plus administration charges at the appropriate rate will be charged extra where stated.
4. Prior to the hire of Port of Cork Company plant / equipment, the user should apply in writing to the Harbour Master on the relevant application form.
5. The rates listed in all Port of Cork Company Schedules are maximum rates. The Port of Cork Company may vary the rates in accordance with the Company's objectives.
6. The rates quoted are exclusive of V.A.T. (unless otherwise stated) , which will be charged where applicable.
